Society Membership Information

Membership in the Society is governed by the following:

1. Membership is limited to persons who are 19 years of age or older.
2. Current Members in good standing may renew their membership by submitting their completed Society Membership Application, paying their \$5 annual fee, up to noon on the day of the AGM. You are a current member if you renewed your membership at last year's AGM.
3. New Applicants: To be eligible to vote at the 2022 AGM, new applicants must have completed and submitted the application form, and paid the \$5 membership fee, prior to Noon on 25 April 2022 in order to meet the deadline for review by the Board.
4. The \$5 Annual Membership Fee is due when membership is applied for. A receipt will be issued for payment of annual membership fees.
5. The Board or its designated committee will review new applications for membership prior to a member being accepted into the Society. Ineligible applicants for membership will be notified and refunded their membership fee.
6. The Society's Membership year runs from noon on the day of the AGM until noon on the day of the following year's AGM.
7. A Member in good standing has the following rights and privileges of membership:
 - a. to receive notice of, and to attend, all General Meetings;
 - b. to make or second motions at a General Meeting; and to speak in debate on motions under consideration in accordance with such rules of order as may be adopted;
 - c. to exercise a vote on matters for determination at General Meetings;
 - d. may be nominated, if qualified to stand for election as a Director, in accordance with the Society Bylaws;
 - e. may nominate qualified persons to stand for election as a Director in accordance with the Society Bylaws;
 - f. may serve on committees of the Society as invited.
8. Members are not in good standing if they did not renew their membership or pay the membership fee when due. Members who are not in good standing may attend the AGM but are suspended from all of the other rights and privileges of membership.
9. A person will immediately cease to be a member of the Society:
 - a. upon the date which is the later of:
 - (1) the date of delivering their resignation in writing to the address of the Society; and
 - (2) the effective date of the resignation stated thereon;
 - b. upon the expiry of the term of membership;
 - c. upon expulsion;
 - d. upon their death.
10. Membership is not transferable.
